On September 21, 2004, NDEP approved the above-identified CAP with comments. To date, this CAP has only partially been implemented. NVE has requested to discontinue implementation of the remaining work proposed in this CAP and address the remaining groundwater, soil, and solids characterization and remediation work associated with Ponds F and G as part of the site-wide Scope of Work attached to the February 22, 2008 Administrative Order on Consent (AOC) between NDEP and NVE. As discussed during a September 24, 2008 meeting between NDEP and NVE, NDEP concurs with this request. The next scheduled update of AOC Scope of Work schedule should include all remaining activities associated with Ponds F and G.
