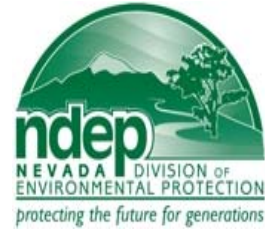

C. Miscellaneous Information

- All information is necessary and if not provided, the application will be rejected.
- A non-refundable renewal fee in the amount of \$100.00 (one hundred) must accompany this application. Please be aware that checks returned by the bank without payment will result in a letter from the State indicating that you will have fourteen (14) days from the date of the letter to make payment of the full amount of the check plus a \$25.00 returned check charge (NAC 353C.400). In addition, a hold will be placed on your file until adequate payment is received.
- The NDEP has six (6) weeks after receipt of a complete application to determine eligibility for renewal.
- If your certification lapses, you cannot legally **continue to provide services as an Environmental Manager, in the State of Nevada.**

- 4) I certify that I will conform to the requirements of NAC 459 related to certification as an Underground Storage Tank Handler.
- 5) I declare that any statement in this application or information provided as part of this application is true and complete. I understand that if I provide false information, I may subject myself to the penalty provisions of NRS 459.595 and appropriate disciplinary action including revocation of certification.
