Notice of Proposed Action

The Administrator of the Division of Environmental Protection gives notice that an application for a new Water Pollution Control Permit (WPCP) for the Pinson Rapid Infiltration Basins (RIBs) has been properly filed with the Division of Environmental Protection in Carson City. The applicant for this new permit, WPCP NEV2005102 is:

The facility is located on private land in Humboldt County, within Township 38N, Range 42E, Sections 28, 29 and 33, Mount Diablo Baseline & Meridian (MDB&M), approximately 37 miles northeast of the town of Winnemucca in Humboldt County, Nevada. The Pinson RIBs will be constructed in conjunction with the Pinson Exploration Project (WPCP NEV2005103), which will involve the development of two exploration declines at the Pinson Mine Site. Over 5 million gallons per day of dewatering water will be removed as a result of the decline development. The water will be allowed to return to the same hydrographic basin through a series of Rapid Infiltration Basins (RIBs).

The Pinson RIBs will consist of a Surge Basin to settle out any sediment and initially two infiltration basins with the potential to expand to a total of four basins, depending on need and actual RIB performance. The RIBs are required to be designed, constructed, operated and closed without any discharge or release in excess of those standards established in regulation except for meteorological events which exceed the design storm event.

The Administrator is constrained to either issue the water pollution control permit, or to deny the application. The Administrator has made the tentative determination to issue the permit.

Persons wishing to comment upon the proposed permit, to recommend terms and conditions for consideration of incorporation in the permit, or who request a public hearing pursuant to the Nevada Administrative Code (NAC) Chapter 445A, must submit their comments, objections, or requests no later than September 22, 2005 to:

All comments or objections received during the public notice period will be considered in the final determination regarding this application. If the Division determines written comments or requests indicate a significant degree of public interest in this matter, the Administrator shall schedule a public hearing in accordance with the requirements of NAC 445A.405.
