## **PUBLIC NOTICE OF PROPOSED ACTION**

**Web Posting Date – June 05, 2006**

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and the Federal Clean Water Act. The Administrator has received an application for renewal of National Pollutant Discharge Elimination System (NPDES) Permit # NV0020869 from the following applicant:

### **Truckee Meadows Water Authority**

**Reno, Nevada 89520**

Truckee Meadows Water Authority (TMWA) operates the Highland Reservoir, located at the corner of Washington Street and Reservoir Road, Reno, Washoe County, Nevada. The Highland Reservoir stores potable drinking water from the TMWA water system, and provides municipal drinking water to the City of Reno and surrounding areas. TMWA seeks renewal of permit NV0020869 to allow for discharge of up to and greater than 1 MGD of treated and disinfected potable drinking water to the City of Reno storm drain system, and ultimately to the Truckee River. Discharge would be in the event of mechanical or operational emergency conditions, after first treating water to be discharged to remove residual chlorine. The Applicant also seeks the permit to discharge small amounts of potable water collected in the reservoir sub-drain system. Discharge flows are dependent on the type and duration of the emergency condition. Based on a review of the NPDES permit application, the Division has made the tentative determination to renew the NPDES permit for a period of five (5) years, subject to certain permit limitations and requirements.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance, or request a hearing pursuant to the Nevada Administrative Code, Water Pollution Control, should submit their comments or request, in writing, within thirty (30) days of the date of newspaper publication, hand-delivered or postmarked no later than **5:00 P.M. on June 29, 2006**, either in person or by mail to:

Comments and/or hearing requests received via facsimile or e-mail before **5:00 P.M. June 29, 2006** will also be accepted. All requests for hearings must indicate the interest of the person filing the request and the reason(s) why a hearing is warranted. All comments or objections received within the thirty (30) day comment period will be considered in the formulation of final determinations regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. The public notice of such hearings will be issued not less than thirty (30) days prior to the public hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.
