NOTICE OF PROPOSED ACTION

Web posting 12/2/09

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes. The Administrator has received an application requesting renewal of water pollution control discharge permit **NEV94008** from the following applicant:

**Gold Ranch RV Park & Casino
Post Office Box 160
Verdi, Washoe County, Nevada 89439-0160**

The Permittee proposes to continue to operate the **Gold Ranch RV Park & Casino**, which is located in Verdi, Washoe County, Nevada. If authorized, this facility would produce up to 25,000 gpd (gallons per day) of tertiary grade effluent from its Hydro-Aerobics Package Plant. This permit would authorize the treated effluent to be discharged from the plant via sub-surface leach fields. The approval would be granted for treatment of domestic sewage only; there would be no discharge of any type of industrial wastewater.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, as amended and implementing regulations, the Administrator proposes to renew permit, **NEV94008**, to discharge for a five (5) year period, subject to effluent limitations.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance, or request a hearing pursuant to the Nevada Administrative Code, Water Pollution Control, should submit their comments or request, in writing, within thirty (30) days of the date of newspaper publication, closing at 5:00 P.M. on **January 9th, 2010**, either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determinations regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.
