NOTICE OF PROPOSED ACTION

Web posting 4/13/10

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes. The Administrator has received a complete application for the renewal of groundwater discharge permit **NEV2004515** from:

For the following facility:

**Callville Bay Water Treatment Plant
560 Screech Owl Road
Callville Bay (Las Vegas), NV 89124**

The Permittee operates a micro filtration water treatment facility which draws raw water from the Lake Mead water intake barge structure into the plant raw water storage tank. Raw water is pumped from the tank, passing through screens and into the 0.2 micron membrane modules (24 membrane filters) of the micro filtration system for treatment. Product water is collected in the clearwell, disinfected with calcium hypochlorite and pumped to the 100,000 gallon or the 300,000 gallon steel potable water storage tanks and from there into the distribution system. Backwash is achieved with a reverse flow of 95 psi compressed air through the membrane modules. The backwash water is discharged to an area for enhancement of desert riparian vegetation. The plant is designed to meet State and Federal water quality requirements and for protection against *giardia cysts* and *cryptosporidium oocysts*.

Persons wishing to comment on or object to the proposed determinations by the Administrator regarding permit issuance, or request a hearing pursuant to the Nevada Administrative Code, Water Pollution Control, should submit their comments or request, in writing, within thirty (30) days of the date of newspaper publication, hand-delivered or postmarked no later than 5:00 P.M. on **May 17, 2010**, either in person or by mail to:

Comments and/or hearing requests received via facsimile or e-mail before 5:00 P.M. **May 17, 2010** will also be accepted. All requests for hearings must indicate the interest of the person filing the request and the reason(s) why a hearing is warranted. All comments or objections received within the thirty (30) day comment period will be considered in the formulation of final determinations regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. The public notice of such hearings will be issued not less than thirty (30) days prior to the public hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.
