## NOTICE OF PROPOSED ACTION

Web posting 10/18/10

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and the Federal Clean Water Act. The Administrator has received an application for National Pollutant Discharge Elimination System (NPDES) Permit NV0023892 from the following applicant:

**Kumiva Group, LLC  
1612 West Pico Boulevard  
Los Angeles, CA 90015**

The Applicant requests an NPDES permit for the discharge of pumped and treated groundwater from a facility located at 1685 South Palm Street, Las Vegas, Clark County, Nevada. The Applicant proposes to extract and treat hydrocarbon contaminated groundwater impacted by a previously leaking underground storage tank, and discharge the treated water, under specific limitations and requirements, to the Las Vegas Wash via the Clark County stormdrain system. The discharge will be limited to a maximum flow of 0.0144 million gallons per day (10 gallons per minute). Based on a review of the NPDES permit application, the Division has made the tentative determination to issue the NPDES permit for a period of five (5) years.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding the issuance of either permit, or to request a hearing pursuant to the Nevada Administrative Code, Water Pollution Control, should submit their comments or request, in writing, within thirty (30) days of the date of newspaper publication, hand-delivered or postmarked no later than **5:00 P.M. on November 19, 2010**, either in person or by mail to:

Comments and/or hearing requests received via facsimile or e-mail before **5:00 P.M. November 19, 2010** will also be accepted. All requests for hearings must indicate the interest of the person filing the request and the reason(s) why a hearing is warranted. All comments or objections received within the thirty (30) day comment period will be considered in the formulation of final determinations regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. The public notice of such hearings will be issued not less than thirty (30) days prior to the public hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments

and objections will be considered at that time.
