## NOTICE OF PROPOSED ACTION

Web posting 4/14/10

The Administrator, Division of Environmental Protection, Department of Conservation and Natural Resources, Carson City, Nevada is issuing the following notice of proposed action under the authority of the Nevada Revised Statutes and the Safe Drinking Water Act.

The Administrator has received an application for an Underground Injection Control (UIC) permit, which has been drafted for public comment. Permit **UNEV2010203** has been applied for by the following applicant:

**Big Daddy's Oil, LLC**  
**3230 East Flamingo Road Suite 8-352**  
**Las Vegas, Nevada 89121**

The applicant has submitted an application for a UIC permit associated with the Flamingo AM/PM #82153, 209 East Flamingo Road, Las Vegas NV. The application is in response to the release of petroleum hydrocarbons (gasoline) from subsurface tanks to soil and groundwater, and need for injection of groundwater following extraction and treatment into a subsurface infiltration gallery on the parcel.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes and the Safe Drinking Water Act, and implementing regulations, the Administrator proposes to issue this permit as stated above.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance or to request a hearing pursuant to Nevada Administrative Code, Water Pollution Control, should submit their comments or request in writing by May 17, 2010 either in person or by mail to:

All comments or objections received within thirty days of newspaper publication will be considered in the formulation of final determinations regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty days prior to the hearing date.
