NOTICE OF PUBLIC MEETING

NOTICE IS HEREBY GIVEN that the Nevada Division of Environmental Protection will hold a public meeting to provide an opportunity for comment on the Draft 2012 Project Priority Lists for Drinking Water State Revolving Fund (DWSRF) and Clean Water State Revolving Fund (CWSRF) funds. Through low-interest loans for infrastructure improvements, the DWSRF is available to assist water systems and the CWSRF is available to assist wastewater treatment plants. In order to be considered for a SRF loan, a project must first appear on the Priority List. Nevada Administrative Code (NAC) 445A.6757 and 445A.768 requires that the Nevada Division of Environmental Protection hold a public participation meeting prior to adoption of the priority lists.
