PUBLIC NOTICE

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Division of Environmental Protection is issuing the following notice.

The Director received an application for a new Class II Air Quality Operating Permit AP1442-3403 from:

The Mustang facility will be located 3 miles east of Beowawe on Pioneer Pass Road, Eureka County, Nevada. The Mustang facility will be located approximately at UTM 549.40 km East by 4,491.10 km North, Zone 11 (Section 11, Township 31 North, Range 49 East within Hydrographic Area 54, Crescent Valley). The Director has prepared tentative determinations regarding the operating permit that, in brief, are the following:

- The new Class II permit is for operation of an aggregate processing plant and hot mix asphalt plant.
- Emissions from the facility will not exceed 23.24 tons/year of PM₁₀, 23.24 tons/year of PM_{2.5}, 64.84 tons/year of NO_x, 4.94 tons/year of SO₂, 67.27 tons/year of VOC, 95.47 tons/year of CO, 4.16 tons/year of HAPs and 31,422 tons/year greenhouse gases, CO₂ equivalent.
- No adverse ambient air quality impacts are expected.

On the basis of the preliminary review of the application and supporting information review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue a new Class II air quality operating permit.
