PUBLIC NOTICE

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Division of Environmental Protection is issuing the following notice.

The Director received an application for a new Class II Air Quality Operating Permit AP1021-3369 from:

The Nevada Copper, Inc. project will be located 8 miles southeast of Yerington, Lyon County, Nevada. The Nevada Copper, Inc. facility will be located approximately at UTM 323.37 km East by 4,311.75 km North, Zone 11 (Sections 2-3-4-9-10-11, Township 12 North, Range 26 East and Section 35, Township 13 North, Range 26 East in Hydrographic Area 108, Mason Valley). The Director has prepared tentative determinations regarding the operating permit that, in brief, are the following:

- The new permit is for new construction and operation of a copper mine and milling facility.
- Emissions from the facility will not exceed 36.56 tons/year of PM₁₀, 7.72 tons/year of PM_{2.5}, 6.45 tons/year of NO_x, 0.27 tons/year of SO₂, 0.54 tons/year of VOC, 4.21 tons/year of CO, less than 0.01 tons/year of HAPs and 673.8 tons/year greenhouse gases, CO₂ equivalent.
- No adverse ambient air quality impacts are expected.

On the basis of the preliminary review of the application and supporting information review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue a new Class II air quality operating permit. Persons wishing to comment upon the proposed determinations by the Director regarding this proposed action should submit their comments in writing either in person or by mail or fax within thirty (30) days to:
