PUBLIC NOTICE

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Division of Environmental Protection is issuing the following notice.

The Director received an application for a new Class II Air Quality Operating Permit AP1321-3368 from:

Colony Energy, Reno LNG, LLC

Newport Beach, CA 92660

The Colony Energy, RENO LNG, LLC project will be located within the Tahoe-Reno Industrial Center on Peru Drive (at Sleeper Way), McCarran, Storey County, Nevada. The Colony Energy, RENO LNG, LLC facility will be located approximately at UTM 283.58 km East by 4,380.84 km North, Zone 11 (Sections 33/4, Township 19/20 North, Range 22 East in Hydrographic Area 83, Tracy Segment). The Director has prepared tentative determinations regarding the operating permit that, in brief, are the following:

- The new permit is for new construction and operation of a liquefied natural gas (LNG) facility.
- Emissions from the facility will not exceed 11.52 tons/year of PM₁₀, 11.52 tons/year of PM_{2.5}, 55.94 tons/year of NO_x, 1.84 tons/year of SO₂, 4.28 tons/year of VOC, and 67.08 tons/year of CO, and 1.83 tons/year of HAPs.
- No adverse ambient air quality impacts are expected.

On the basis of the preliminary review of the application and supporting information review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue a new Class II air quality operating permit. Persons wishing to comment upon the proposed determinations by the Director regarding this proposed action should submit their comments in writing either in person or by mail or fax within thirty (30) days to:
