## NOTICE OF PROPOSED ACTION

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and/or the Clean Water Act, where applicable. The Administrator has received an application for a New Manufacturing, Commercial, Mining and Silvicultural Discharge, permit number NV0024202 from the following applicant:

### Permit NV0024202, SUNSET REGIONAL PARK SPLASH PAD:

The Sunset Regional Park Splash Pad is a recreational play water feature located within the park boundaries. Water from a municipal source is sprayed onto a splash pad designed for children to play on. The water is supplied to the pad from multiple spray elements. Water from the splash pad flows into two (2) water feature drains which lead to a sand/oil separator. The discharge then flows through a drain line to a municipal storm drain located at Sunset Road and ultimately to Las Vegas Wash. The requested discharge flow for this facility is 0.13 million gallons per day (MGD).

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, as amended, and implementing regulations, the Administrator proposes to issue Permit NV0024202 to discharge for a five (5) year period, subject to certain effluent limitations.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance, or request a hearing pursuant to the Nevada Administrative Code, Water Pollution Control, should submit their comments or request, in writing, within thirty (30) days of the date of newspaper publication, hand delivered or postmarked no later than 5:00 P.M. on 03/15/2013, either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determination(s) regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.
