NOTICE OF PROPOSED ACTION

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and/or the Clean Water Act, where applicable. The Administrator has received an application for a Manufacturing, Commercial, Mining and Silvicultural facility that discharges NON-PROCESS Wastewater, permit number NV0024210 from the following applicant:

Permit NV0024210, LAS VEGAS WASH CHANNEL IMPROVEMENT PROJECT:

Clark County Water Reclamation District (CCWRD) has applied for a new National Pollutant Discharge Elimination System permit to discharge groundwater generated during dewatering activities associated with CCWRD project #511D. All discharges will be to the Las Vegas Wash (Wash). This project is designed to help convey the 100-year flow through CCWRD's Central Plant property, improve the access road across the Wash, and mitigate channel degradation. Improvements will include the installation of five 6' high by 30' wide reinforced concrete box culverts, the placement of riprap along a portion of the Wash, construction of a concrete lined channel, construction of a 10' vertical drop/grade control structure, and the relocation and installation of new and existing utilities.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, as amended, and implementing regulations, the Administrator proposes to issue Permit NV0024210 to discharge for a five (5) year period, subject to certain effluent limitations.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance, or request a hearing pursuant to the Nevada Administrative Code, Water Pollution Control, should submit their comments or request, in writing, within thirty (30) days of the date of newspaper publication, hand delivered or postmarked no later than 5:00 P.M. on 08/16/2013, either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determination(s) regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations.

Additional comments and objections will be considered at that time.
