

NOTICE OF PROPOSED ACTION

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Division of Environmental Protection is issuing the following Notice of Proposed Action.

The Director received an application for a Class I Air Quality Operating Permit to Construct (OPTC) AP1041-3344 (FIN A0390) from the following applicant:

Hycroft Resources & Development, Inc.

Winnemucca, Nevada 89446

Hycroft Resources & Development, Inc. is located in Humboldt County, approximately 55 miles west of Winnemucca, Nevada off of Jungo Road in Humboldt County. The project is located in all or portions of the following area: Sections 1 and 2, Township 34N, Range 29E, Sections 13, 23 through 27, and 34 through 36, Township 35N, Range 29E, and Sections 17 through 20, and 30 through 32, Township 35N, and Range 30E (MDB&M). The Director has prepared a tentative determination regarding the OPTC that, in brief, includes the following:

- Hycroft Resources & Development, Inc. proposes to operate six lime silos, four emergency generators, and re-tasked equipment from AP1041-2974 onto OPTC AP1041-3344. The proposed activities will add to the facility's PTE profile for all criteria pollutants.

On the basis of the preliminary review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue the Class I Air Quality Operating Permit to Construct based on a review of the information submitted.
