



**NOTICE OF PUBLIC WORKSHOPS  
Proposed Regulation P2015-04  
Bureau of Mining Regulation and Reclamation**

The Bureau of Mining Regulation and Reclamation (BMRR) of the Division of Environmental Protection (Division) is proposing to adopt a regulation (P2015-04) amending Chapter 519A of the Nevada Administrative Code (NAC); Mining Reclamation Regulations. Workshops will be held August 4 and August 12, 2015, at the following locations and times, to discuss the proposed changes and to receive comments from persons interested in the proposed regulatory amendment generally described below. The proposed revisions to NAC 519A would provide the regulatory authority for the Division to address mine impacted waters, including contaminated surface water, groundwater, and seepage from waste rock storage facilities, open pits, and underground mines. If a mining operation had environmental liabilities related to mine impacted waters, the stabilization, management, control, or treatment of the mine impacted waters to prevent degradation of waters of the State and/or adverse effects to the health of human, terrestrial, or avian life would need to be addressed in the reclamation plan. The regulatory amendment would allow the Division to require costs associated with the reclamation measures appropriate for existing mine impacted waters be included in the project reclamation bond, and provide the authority to establish financial guarantee amounts for long-term fluid management costs, such as perpetual treatment, if warranted. The proposed regulation would also provide clarification that an operator may file a cash deposit with the Division to ensure that reclamation will be completed.
