PUBLIC NOTICE

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Division of Environmental Protection is issuing the following notice.

The Director received an application for a new Class II Air Quality Operating Permit AP2047-3612 from:
Clean Dried Processing, Inc.
600 Lake Avenue
Silver Springs, Nevada 89429

The project is located in Silver Springs, Nevada, in Lyon County, Nevada at approximately 4,364.10 km North by 307.90 km East, UTM Zone 11 (Section 24, Township 18 North, Range 24 East in Hydrographic Area 102 – Churchill Valley). The Director has prepared tentative determinations regarding the operating permit that, in brief, are the following:

- The new permit is for a facility that converts vegetable or food-byproducts into dried pet food ingredients using a rotating drum dryer and conveys them to stockpiles within a building.
- Emissions from the facility will not exceed 0.53 tons/year of PM₁₀, 0.46 tons/year of PM_{2.5}, 5.72 tons/year of NO_x, 0.03 tons/year of SO₂, 0.31 tons/year of VOC, and 4.80 tons/year of CO.
- No adverse ambient air quality impacts are expected.

On the basis of the preliminary review of the application and supporting information review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue a new Class II air quality operating permit. Persons wishing to comment upon the proposed determinations by the Director regarding this proposed action should submit their comments in writing either in person or by mail or fax within thirty (30) days to:
