



## NOTICE OF PROPOSED ACTION

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and/or the Clean Water Act, where applicable. The Administrator has received an application for a Groundwater Discharge , permit number NS2001507 from the following applicant:

### **Permit NS2001507, RLP RANCH INC.:**

The Permittee, RLP Ranch Inc., proposes to continue applying domestic septage, portable toilet fluid, and grease interceptor material (domestic septage) to a 60-acre parcel of nutrient-deficient agricultural land located approximately half a mile north of the Elburz I-80 exit on County Road 745 in Elko County, Nevada. The domestic septage applied to the site must be incorporated into the soil within six hours of land application. The rate of land application is limited by the nitrogen uptake of the crop to be grown. The Permittee is required to plant a crop to utilize the nitrogen within one year of land application.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, as amended, and implementing regulations, the Administrator proposes to issue Permit NS2001507 to discharge for a five (5) year period, subject to certain effluent limitations.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance, or request a hearing pursuant to the Nevada Administrative Code, Water Pollution Control, should submit their comments or request, in writing, within thirty (30) days of the date of newspaper publication, hand delivered or postmarked no later than 5:00 P.M. on 05/20/2015 , either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determination(s) regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.
