



## NOTICE OF PROPOSED ACTION

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and/or the Clean Water Act, where applicable. The Administrator has received an application for a Groundwater Discharge , permit number NS0097022 from the following applicant:

### **Permit NS0097022, BOULDER CITY WASTEWATER TREATMENT PLANT:**

Boulder City applied to renew its discharge permit for its wastewater treatment facility. The WWTF is designed to treat a daily average flow of 2.5 million gallons per day (MGD) with a maximum daily flow of 3.5 MGD of domestic wastewater in a series of aerated lagoons. This permit does not vary substantially from the previous permit. Treated effluent is disinfected and can be discharged to two earthen percolation trenches for disposal or it can be used for dust control and construction water.

Currently, all of treated effluent is used for gravel washing activities at the Quarry 187, LLC sand and gravel quarry (Permit NS0093013) and dust control and construction water on the I-11 Boulder City Bypass Project (Permit NS2015507).

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, as amended, and implementing regulations, the Administrator proposes to issue Permit NS0097022 to discharge for a five (5) year period, subject to certain effluent limitations.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance, or request a hearing pursuant to the Nevada Administrative Code, Water Pollution Control, should submit their comments or request, in writing, within thirty (30) days of the date of newspaper publication, hand delivered or postmarked no later than 5:00 P.M. on 05/31/2016 , either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determination(s) regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.
