## NOTICE OF PROPOSED ACTION

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and/or the Clean Water Act, where applicable. The Administrator has received an application for a Groundwater Discharge, permit number NS0098023 from the following applicant:

ANTHEM COUNTRY CLUB ONE CLUB SIDE DRIVE HENDERSON, NV - 89052

## Permit NS0098023, ANTHEM COUNTRY CLUB GOLF COURSE:

The Permittee, Anthem Country Club, has applied for the renewal of permit NS0098023 for the Anthem Country Club Golf Course, located in Clark County, Nevada. The Anthem Country Club Golf Course is an 18-hole championship golf course which utilizes partially denitrified treated effluent supplied by the Kurt R. Segler Water Reclamation Facility (KRSWRF - Permit NS0080003). The treated effluent is used for spray irrigation of turf grass and plant materials on the golf course facilities and common areas. The Category B reuse water irrigation is done in accordance with the approved Effluent Management Plan and the terms and conditions of the permit.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, as amended, and implementing regulations, the Administrator proposes to issue Permit NS0098023 to discharge for a five (5) year period, subject to certain effluent limitations.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance, or request a hearing pursuant to the Nevada Administrative Code, Water Pollution Control, should submit their comments or request, in writing, within thirty (30) days of the date of newspaper publication, hand delivered or postmarked no later than 5:00 P.M. on 07/27/2016, either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determination(s) regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.
