

## NOTICE OF PROPOSED ACTION

### PUBLIC NOTICE

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Division of Environmental Protection is issuing the following notice.

The Director received an application for a new Class II Air Quality Operating Permit AP 1041- 3722 from:  
Klondex Midas Operations Inc.  
2720 Ruby Vista Drive  
Elko, Nevada 89801

The project is located approximately 2.5 miles southeast of Midas, Nevada; in Elko County, Nevada. The Director has prepared tentative determinations regarding the operating permit that, in brief, are the following:

- The new Class II operating permit is for new construction and operation of a gold mining facility.
- Emissions from the facility will not exceed 24.45 tons/year of PM<sub>10</sub>, 22.73 tons/year of PM<sub>2.5</sub>, 30.10 tons/year of NO<sub>x</sub>, 1.92 tons/year of SO<sub>2</sub>, 2.13 tons/year of VOC, 12.08 tons/year of CO, and 0.00 tons/year of H<sub>2</sub>S.
- No adverse ambient air quality impacts are expected.

On the basis of the preliminary review of the application and supporting information review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue a revised Class II air quality operating permit.
