

# Voluntary Continuing Education

Became Effective January 1, 2010

- Grades I (1) & II (2): 5 contact hours
- Grades III (3) & IV (4): 10 contact hours
- Grades V: 10 contact hours
- Check the continuing education box on the renewal form.
- Submit documentation of contact hours.  
Documentation must include your name, # of hours and the type of training.

# Voluntary Continuing Education Cont.

- Once the documentation is reviewed you will receive a Continuing Education Endorsement Sticker.
- Note: 50 % must be directly related to your certification with only 20% coming from safety classes.


