Chemical Accident Prevention Program (CAPP) Regulatory Amendment: Fee Revision for Permit Applications and Annual Fees – Overview

### <u>Overview</u>

The Nevada Division of Environmental Protection – Bureau of Air Pollution Control – Chemical Accident Prevention Program (CAPP) is proposing an amendment to the fee schedule and regulations. Fee increases will ensure CAPP can continue to perform its statutory requirements including permitting, annual inspections of facilities, and appropriate staffing and staff development. The fees were last increased almost 20 years ago. Without the fee increase, revenue will not balance with program expense projections.

## The new fee schedule is proposed to be effective when the regulation is passed with the annual fees being effective July 1, 2023.

### Major Changes

CAPP is proposing to change the following:

- An increase of the annual registration fee per the consumer price index to account for inflation since the last fee change.
- An increase of the permitting hourly rate fee per the consumer price index to account for inflation since the last fee change.
- An increase of the investigation fee per the consumer price index to account for inflation since the last fee change.
- A new fee for Confidentiality Determinations.
- A new "Change of Ownership" fee.
- A defined unit of explosives for fee purposes.
- An optional 2% increase to the annual, permitting, and investigation fees each year to avoid large increases in the future.

Introduction

The NDEP CAPP Program is proposing a regulatory change to amend its fee schedule.

The change seeks to update the Program's approach to how fees are assessed, and to increase the fees across the regulated industry to reflect inflation with workload and resources required to implement NDEP's CAPP Program.

Ultimately, the change will allow the CAPP Program to respond to present and future challenges in the regulated industry, to continue to provide effective regulatory oversight of activities involving the handling of hazardous substances by minimizing the risk of chemical accidents, and to maintain a vibrant economy in Nevada.
