### TEMPORARY DISCHARGE PERMIT APPLICATION INSTRUCTIONS

**PROCEDURES FOR FILING** - A form fill version of the application is available at the Bureau of Mining Regulation and Reclamation website at [Regulation Branch Applications and Fees](#). Additional information sufficient to describe and explain the proposed activity must be included with the completed form, Nevada Administrative Code (NAC) 445A.230. Contents of the supporting information are detailed in the regulations governing temporary discharge permits, NAC 445A.228 through 445A.263.

**SIGNATURE ON APPLICATION** - The permit application must be signed by the owner or, for partnership or corporation, an executive officer whose name appears in Part 1. If the owner does not operate the facility then the operator or his designated agent must also sign the application, NAC 445A.231.

**USE OF INFORMATION** - All information contained in this application will, upon request, be made available to the public for inspection and copying.

**APPLICABILITY** - This application applies only to waters that are not waters of the U.S. If the proposed temporary discharge will be to a water of the U.S., then the applicant must apply to the Bureau of Water Pollution Control.

The discharge for well pump tests does not require a permit if the following three (3) conditions are met: 1) The discharge is less than 250 gallons per minute; 2) The test is for less than 48 hours in duration; and 3) The discharge water will not cause a violation of any water quality standard.

A temporary permit may be issued for a 180-day maximum period of time, pursuant to Nevada Revised Statutes (NRS) 445A.485, after which time the discharge shall cease or the discharger shall have applied for and received a five (5) year Discharge Permit, NRS 445A.495. A \$250.00 fee is due at the time of application, NAC 445A.232.

A temporary permit may be issued once for a 180-day maximum period of time, pursuant to Nevada Revised Statutes (NRS) 445A.485, after which time the discharge shall cease or the discharger shall have applied for and received a five (5) year Discharge Permit, NRS 445A.495. A \$250.00 fee is due at the time of application, NAC 445A.232.

**3. Receiving Water:** Specify if the discharge is to surface water or groundwater. If the discharge is to surface water, provide the name of receiving water into which the system discharges and the name of the owner of the drainage. \_\_\_\_\_

**4. Narrative Description:** Site and activities that require the discharge permit (e.g. well pump tests, release of excess drilling water, mine dewatering activities). Describe any treatment system and/or Best Management Practices to be used at the facility.

**5. Water Quality Analysis:** Nevada-certified Lab Profile I analysis to include the potential contaminants/pollutants in the discharge (additional analysis may be required for discharges to surface water).

**6. Quantity of discharge:** The estimated flow rate in gallons per day (gpd) for each discharge point and total for the site/facility.

7. **Map:** Attach a topographic map and a site/facility map showing the location of the proposed discharge and a line drawing showing the route taken by water in the facility from intake to discharge. Include pertinent water bodies, discharge point(s), and conveyance location(s) with their latitude and longitude.

8. **Existing and or pending Water Pollution Control and Reclamation Permits:** List

9. **Ownership:** The applicant must demonstrate proof of ownership of receiving location of the discharge or demonstrated proof of authorization to discharge to the receiving location prior to issuance of a permit by the Division.

Any person who knowingly makes any false statement, representation, or certification in an application, record, report, plan, or other document filed or required to be maintained by the provisions of NRS 445A.130 to 445A.730, inclusive, or who falsifies, tampers with, or knowingly renders inaccurate any monitoring device or method required to be maintained under the provisions of NRS 445A.130 to 445A.730, inclusive, or by any permit, rule, regulation, or order issued pursuant thereto, is subject to remedies and sanctions as provided in NRS 445A.675, to-wit, not more than \$25,000 per day per violation or imprisonment for not more than one year or both.
