## Lead Compliance Data for Nevada Public Water Systems

The table below shows the 90th percentile Lead level for three-hundred-thirty-nine (339) public water systems (PWSs) that are currently subject to the Lead and Copper Rule. The USEPA sets the 90th percentile Action Level (AL) for Lead at 0.015 mg/L. If a water system's Lead concentrations exceed the AL in more than 10% of the samples, the system must undertake additional actions to investigate the source of Lead and control corrosion in the pipes of the distribution system. The system must also inform the public about the steps they should take to protect their health (Public Education) and may have to replace lead service lines under their control.
