#### Describe the manner in which comment was solicited from affected small businesses, a summary of the response from small businesses and an explanation of the manner in which other interested persons may obtain a copy of the summary. The Nevada Division of Environmental Protection, Bureau of Water Pollution Control will hold a regulatory workshop to engage with it's regulated community on this proposed regulatory amendment. However, NDEP does not anticipate that the proposed regulation will impose a direct and significant economic burden upon a small business; nor does it restrict the formation, operation or expansion of a small business because the higher proposed fee increases for individual, 5-year permits, are tied to the National Consumer Price Index and their implementation has been delayed until July 1, 2023 to allow the regulated community time to plan for the increase. NDEP intends to solicit more feedback from permittees regarding the proposed fee increases during the workshop process.

#### 2. The manner in which the analysis was conducted (if an impact was determined).

A majority of the fees that are proposed for an increase are to align these fees with the Consumer Price Index (CPI). These fees have not increased since 2010. NDEP intends to implement the fee increases over a three-year period to lessen the burden on small business. NDEP intends to solicit more feedback from permittees regarding the proposed fee increases during the workshop process.

### 3. The estimated economic effect of the proposed regulation on small businesses:

An economic effect on small business is not expected.

a. Both adverse and beneficial effects:

Permit applicants will be required to pay increased fees to obtain necessary permits from the BWPC which could be viewed as an adverse effect. NDEP will hire new staff with the increased revenue. This will provide a beneficial effect to the public as more staff will be available to review and issue permits more timely, to inspect our permitted facilities and also to bring these facilities back into compliance more expeditiously. In addition, more staff will provide additional individuals to respond to public inquiries.

b. Both direct and indirect effects:

The direct effect of the regulation change will be increased fees for applicants. The fee increases for individual permits are proposed to be implemented over a three-year period to reduce direct impacts on any small business. Fee increases for small general permits were kept low to minimize impacts as well. 4. A description of the methods that the agency considered to reduce the impact of the proposed regulation on small businesses and a statement regarding whether the agency actually used any of the methods. A majority of the fees that are proposed for an increase are to align these fees with the Consumer Price Index (CPI). These fees have not increased since 2010. NDEP intends to implement the fee increases over a three-year period to lessen the burden on small business. NDEP intends to solicit more feedback from permittees regarding the proposed fee increases during the workshop process.

A. Simplification of the proposed regulation:

NDEP made efforts to ensure that only minimal fee increases were proposed for the typical permits used by small business and the public.

There is no cost to the agency for enforcement of the proposed regulations.

The increased revenue will be used to increase fiscal sustainability, ensure the program can keep pace with expenses, hire additional staff to timely review and approve permit applications, to ensure adequate technical services are available for our permittees, to ensure timely and necessary compliance and enforcement actions are initiated and to provide the necessarily administrative assistance to the public. Fee increases will be used to cover the revenue needed for merit and COLA increases for existing staff. Staffing levels are currently not sufficient to adequately respond to increasing permit applications, technical review requests and compliance issues througout the state. These shortfalls in permitting and compliance have been documented in audits conducted by EPA.

# 7. If the proposed regulation includes provisions which duplicate or are more stringent than federal, state or local standards regulating the same activity, provide and explanation of why such duplicative or more stringent provisions are necessary.

The proposed regulations do not regulate the same activity as a federal statute or regulation.

A majority of the fees that are proposed for an increase are to align these fees with the Consumer Price Index (CPI). These fees have not increased since 2010. NDEP intends to implement the fee increases over a three-year period to lessen the burden on the regulated community and small business. NDEP intends to solicit more feedback from permittees regarding the proposed fee increases during the workshop process.
