Subject: Modification of Permit SW495REV01 (Permit) and removal of Compliance Item 9.1.1.1.

Dear Mr. Pattalock:

Please find enclosed the modified Jungo Landfill Permit (Permit). The Nevada Division of Environmental Protection (Division) has modified the permit to correct the name of the Operator listed on the face of the Permit and to include the name of the new Owner of the land upon which the Permit is based, as requested in the attached letter from Erin Merrill to Jon Taylor dated August 17, 2012. Specifically, we have corrected the name of the Operator from Recology, Inc. to Jungo Land & Investments, Inc. Jungo Land & Investments, Inc. is a wholly-owned subsidiary of Recology Nevada, Inc. which, in turn, is a wholly-owned subsidiary of Recology, Inc. Although Jungo Land & Investments, Inc. has always been the permitted Operator, its name was erroneously mis-identified on the face of the final permit. Jungo Land & Investments, Inc. is the entity that was identified as the Operator on the application for the Permit and is also the entity that provided the financial assurances pursuant to NAC 444.6851-NAC 444.6859. We have also updated the name of the Owner of the land from Nevada Lands and Resource Company, LLC to its wholly-owned subsidiary, New Nevada Lands, LLC.

In accordance with NAC 444.6435, the Division is transmitting the modified Permit without proceeding to public comment as there has been no change in the Financial Assurance for the site pursuant to NAC 444.6435(3)(d). Also as requested, compliance item 9.1.1.1 has been removed from the Permit as the Division has confirmed with Humboldt County that compliance has been attained (see attached).
