PUBLIC NOTICE FOR DRAFT RCRA PERMIT FOR A HAZARDOUS WASTE TREATMENT, STORAGE AND DISPOSAL FACILITY

<p>What is the Public Notice About?</p>	<p>This is a REQUEST FOR PUBLIC COMMENT on a DRAFT PERMIT issued under the Resource Conservation and Recovery Act (RCRA) for the storage, treatment, and disposal of hazardous waste at a facility operated by US Ecology Nevada, Inc. (USEN) located 11 miles south of Beatty, Nevada. Under the terms of the DRAFT PERMIT, USEN may continue to receive and manage hazardous waste as identified and described in the APPLICATION. The facility is also required to continue groundwater monitoring and corrective action and will conduct closure and post-closure care activities upon partial and/or final closure of the facility.</p>

<p>When is the Public hearing?</p>	<p>A Public Hearing has not been scheduled for this Permit renewal. A hearing will be scheduled if there are significant questions or comments related to the DRAFT PERMIT. All who are on the mailing list or who have submitted comments will be notified at that time should a hearing be scheduled.</p>
<p>When does the comment period end?</p>	<p>As specified above, the 45-day comment period ends March 15, 2005. Anyone wishing to comment should do so in writing prior to this date. If there is significant public interest or concern, the Division will extend the comment period for no more than 30 days.</p>
