Notice of Proposed Action

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and the Clean Water Act. The Administrator has received a complete application for a National Pollutant Discharge Elimination System Permit, NV0021067, from the following applicant:

The Permittee proposes to continue to discharge untreated groundwater from a sump in the basement of the Club Cal Neva Nevadan Hotel, the former Riverboat/Onslow Hotel and Casino, 133 North Virginia Street, Reno at a maximum 7-day average rate of 0.0495 million gallons per day. The pumped groundwater will be discharged to the Truckee River via the City of Reno Stormdrain System. Monitoring will be required to ensure that the Truckee River is not degraded by the discharge.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, as amended, and implementing regulations, the Administrator proposes to issue Permit NV0021067 to discharge for a five (5) year period, subject to certain effluent limitations.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance, or request a hearing pursuant to the NAC, Water Pollution Control, should submit their comments or request, in writing, within thirty (30) days of the date of newspaper publication, hand delivered or postmarked no later than 5:00 P.M. on December 21, 2006, either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determination(s) regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.
