Notice of Intent

The Administrator of the Division of Environmental Protection gives notice that an application for a major modification to a Reclamation Permit for a Mining Operation for the Gold Wedge Project has been properly filed with the Division of Environmental Protection in Carson City. The applicant for Permit #0211 is:

This is an existing mining project located near community of Manhattan, in Nye County, Nevada and is in Sections 18 and 19, Township 8 North, Range 44 East, M.D.B. & M. The operation is an underground mine located on 21 acres; the majority is privately owned land. Surface components will include: a decline, ore stockpile, waste rock dump, fines/oversize pad, settling ponds, shop building, and a physical separation mill. The shop and mill buildings will remain in support of an industrial post-mining land use. This permit modification permits additional surface disturbance associated with a new rapid infiltration basin and waste rock storage facility, and other minor ancillary facilities.

The Administrator is constrained to issue the reclamation permit or to deny the application. The Administrator has made the tentative decision to issue the reclamation permit.

Persons wishing to comment upon the proposed permit, to recommend terms and conditions for consideration of incorporation in the permit, or who request a public hearing pursuant to the Nevada Administrative Code, NAC Chapter 519A, must submit their comments, objections, or requests in writing no later than by 5 PM on November 23, 2008.

If the Division determines written comments or requests indicate a significant degree of public interest in this matter, the Administrator shall schedule a public hearing in accordance with the requirements of NAC 519A.200.
