The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes. The Administrator has received an application for renewal of water pollution control discharge permit # NEV87032 from the following applicant:

The applicant operates a 160,000 gallons/day capacity pond treatment facility, which discharges treated pond effluent to infiltration basins. The current discharge rate of treated effluent is 73,000 gallons/day. The treatment facility serves 831 residents residing in the Hadley subdivision of Round Mountain, Nye County. During this permit term, the facility will enact an action plan to remove accumulated sludge in the three treatment ponds and inspect the liners after 20 years of operation. The Division has made the tentative determination to issue the proposed permit conditions for a five (5) year term.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance, or request a hearing pursuant to the Nevada Administrative Code, Water Pollution Control, should submit their comments or request, in writing, within thirty (30) days of the date of newspaper publication, hand-delivered, e-mailed, faxed or postmarked no later than 5:00 P.M. PST on Monday, January 19, 2009, either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determinations regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.
