NOTICE IS HEREBY GIVEN that the Nevada Division of Environmental Protection will hold a public workshop to provide an opportunity for comment on the proposed 2010 Project Priority List for expenditures of Drinking Water State Revolving Fund (DWSRF) Program funds. The DWSRF, administered by the Division of Environmental Protection, is available to assist water systems through low-interest loans for infrastructure improvements. In order to be considered for a DWSRF loan, a project must first appear on the Priority List. Nevada Administrative Code (NAC) 445A.6757 requires that the Nevada Division of Environmental Protection hold a public participation workshop prior to the Board for Financing Water Projects considering the Priority List for adoption.

The proposed 2010 Priority List will be presented to the Board for Financing Water Projects for approval at its next meeting on September 10, 2009.
