Description of Proposed Permit Modification

Recology has requested a modification to the current permit to include changes to the following:

1. Revise the final Grading Plan
2. Revise the Vadose Zone Monitoring Plan
3. Update the Engineering Report
4. Update the Plan of Operations

The Crestline Landfill provides waste services to the local communities of Pioche, Caliente and outlying areas of rural Nevada.

Proposed Action

The Nevada Division of Environmental Protection (NDEP) is proposing is issuing this notice of intent to modify the Permit.

The Nevada Division of Environmental Protection's (NDEPs) Notice of Intent to approve a modification to the Permit for Recology Crestline Landfill subject to the conditions contained in the Permit, will be published in the **Lincoln County Record**. Additionally, the Public Notice will be mailed to interested persons on our mailing list. The NDEP will accept written comments and written requests for a public hearing on the proposed draft permit from all interested persons. Written requests for a public hearing must state the nature of the issues, which the requester intends to raise at the hearing. Written requests for a public hearing and written comments on the proposed draft permit will be accepted until the end of the public comment period.

Will there be a public hearing?

The NDEP may schedule a public hearing on its own initiative or based on receipt of a written request received during the public comment period. Any interested person may submit a written request to the NDEP for a public hearing on the proposed action. The request must state the nature of the issues which the

requester intends to raise at the hearing. If a hearing is scheduled, the NDEP will notify all persons who are on the mailing list or who have submitted written comments on the proposed action.

When does the comment period end?

The 30-day comment period ends at 5 p.m. on May 21st 2010. Anyone wishing to comment should do so in writing prior to this date. The NDEP may extend the comment period as deemed necessary.
