Description of Proposed Permit Modification

The applicant is seeking authorization to accept the following Industrial Solid Wastes at the Western Elite facility [11S/62E/MDB&M, APN 08-201-02], approximately 65 miles north of Las Vegas in Lincoln County, Nevada:

- Industrial Wash Water Sump and Grease Trap Wastes
- Asbestos
- Coal Combustion Byproducts
- Water Treatment Plant Solids/Biosolids
- Pulp and Paper Solids

Proposed Action

On the basis of the request, the Administrator proposes to conduct a Public Hearing pursuant to NAC 444.6415 on the item to re-issue a permit to operate a landfill as described in the permit application. The applicant or any interested persons may comment on this action by submitting their comments in writing, , no later than 5:00 pm on October 29th 2010. The public hearing will be held in Pioche at the Town Hall at 6:00 PM on October 20th 2010.

All comments received by October 29th 2010 will be addressed in final determinations regarding the application. The Administrator may extend the period for public review as deemed necessary..

The Nevada Division of Environmental Protection's (NDEPs) Public Hearing to approve a modification to the Permit for Western Elite subject to the conditions contained in the Permit, will be published in the Lincoln County Record and Las Vegas Review Journal. Written requests for a public hearing must state the nature of the issues, which the requester intends to raise at the hearing. Written requests for a public hearing and written comments on the proposed draft permit will be accepted until the end of the public comment period.

Will there be a public hearing?

When does the comment period end?

The 30-day comment period ends at 5 p.m. on October 29th 2010. Anyone wishing to comment should do so in writing prior to this date. The NDEP may extend the comment period as deemed necessary.
