PUBLIC NOTICE

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Division of Environmental Protection is issuing the following notice.

The Director received an application for a revision to Class II Air Quality Operating Permit AP1611-2783 from:

Road and Highway Builders, LLC
500 Nevada Boulevard
Lovelock, Nevada 89419

The project is located southwest of Lovelock, Nevada on I-80, in Pershing County, Nevada. The Director has prepared tentative determinations regarding the operating permit that, in brief, are the following:

- The revised permit is for new construction and operation of a lime marination and hot asphalt plant
- Emissions from the facility will not exceed 11.96 tons/year of PM₁₀, 49.66 tons/year of NO_x, 10.23 tons/year of SO₂, 19.14 tons/year of VOC, and 52.92 tons/year of CO.
- No adverse ambient air quality impacts are expected.

On the basis of the preliminary review of the application and supporting information review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue a revised Class II air quality operating permit.
