PUBLIC NOTICE OF PROPOSED ACTION

Web posting 4/21/11

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes. The Administrator has received an application for the renewal of discharge permit # NEV90033 from the following applicant:

AES Industries, Inc.
P.O. Box 781147
Tallassee, AL 36078

The Permittee owns the AES Industries, Inc. manufacturing facility located at 270 U.S. Hwy 95A North in Yerington (Wabuska), Lyon County, Nevada. The AES Facility is permitted for the discharge (evaporative storage) of process wastewater in two single-lined holding ponds both equipped with a leak detection well. The ponds are designed for a daily capacity of 10,000 gallons per day, but presently no process flow is being discharged into the ponds due to a shutdown of a former, plastics manufacturing line located at this site. Presently, the ponds are in use for fire storage. The Division has made the tentative determination to renew the permit conditions to the applicant for a period of five (5) years.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance, or request a hearing pursuant to the Nevada Administrative Code, Water Pollution Control should submit their comments or request, in writing, within thirty (30) days of the date of newspaper publication, hand-delivered, e-mailed, faxed or postmarked no later than 5:00 P.M. PST on Monday, May 30, 2011, either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determinations regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations.

Additional comments and objections will be considered at that time. The application, proposed permit, comments received, and other information are on file and may be copied or copies may be obtained by writing to the above address or by calling Mark A.
