NOTICE OF PROPOSED ACTION AND PUBLIC HEARING

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Division of Environmental Protection is issuing the following Notice of Proposed Action and Public Hearing.

The Director received an application for a Class I Operating Permit-to-Construct (OPTC) AP1041-2971 (FIN A0002) from the following applicant:

Newmont Mining Corporation - Gold Quarry Operations Area (NMC-GQ)
1655 Mountain City Highway
Elko, Nevada 89801

NMC-GQ is located in Eureka County, Nevada, approximately 6 miles northwest of Carlin, NV on State Route 766 (Interstate 80, Exit 280). The project is located in portions of the following areas: Section 1 of T33N, R51E; and Section 36 of T34N, R51E (MDB&M). The Director has prepared a tentative determination regarding the OPTC that, in brief, includes the following:

- X NMC-GQ proposes to add three new retorts to the refinery at NMC-GQ. As such, the following equipment and processes are included in the draft OPTC: Existing and new gold refining equipment includes induction furnaces, carbon kilns, electrowinning cells, current and new retorts and a carbon stripping circuit.

On the basis of the preliminary review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue the Class I OPTC based on a review of the information submitted. A copy of the draft permit will be available for public inspection at the following location:

Written comments or objections will be retained and considered prior to final action on the Class I operating permit. Comments or objections must be received at the above address by **April 15, 2012**. Upon a valid written request received prior to the end of the comment period, the Administrator may schedule a public hearing on the application and proposed action.
