## NOTICE OF PROPOSED ACTION

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes. The Administrator has received a complete renewal application for groundwater discharge permit NS2003500, formerly NEV2003500, from the following applicant:

**Edgewood Companies

Minden, NV 89423**

The applicant has requested to continue using secondary-treated, disinfected reclaimed water for flood irrigation of a 1,025-acre portion of Park Ranch located east of the East Fork of the Carson River, approximately 2.5 miles northwest of the Town of Minden. The Category D reclaimed water, which is supplied by the Minden-Gardnerville Wastewater Treatment Facility (NEV40027), is to be used in accordance with an Effluent Management Plan submitted to, and approved by, the Nevada Division of Environmental Protection.

The Division has made the tentative determination to renew the proposed permit for a period of five (5) years.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance, or request a hearing pursuant to the Nevada Administrative Code, Water Pollution Control, should submit their comments or request, in writing, within thirty (30) days of the date of newspaper publication, hand-delivered or postmarked no later than **5:00 P.M. on December 17, 2012**, either in person or by mail to:

Comments and/or hearing requests received via facsimile or e-mail before **5:00 P.M. on December 17, 2012**, will also be accepted. All requests for hearings must indicate the interest of the person filing the request and the reason(s) why a hearing is warranted. All comments or objections received within the thirty (30) day comment period will be considered in the formulation of final determinations regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. The public notice of such hearings will be issued not less than thirty (30) days prior to the public hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.
