## NOTICE OF PROPOSED ACTION

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and/or the Clean Water Act, where applicable. The Administrator has received an application for a Groundwater Discharge, permit number NS2007504 from the following applicant:

### **Permit NS2007504, STALLION MOUNTAIN COUNTRY CLUB:**

The applicant has requested to continue using tertiary treated, disinfected reclaimed water for irrigation at Stallion Mountain Country Club, a 160 acre championship golf course located in Las Vegas, Nevada. The Category B reclaimed water, which is supplied by the City of Las Vegas Water Pollution Control Facility (Permit NS0098015), is authorized to be applied at a daily maximum flow of 3.0 million gallons per day (MGD) and a 30-day average flow of 2.0 MGD. Irrigation activities shall be conducted in accordance with an Effluent Management Plan submitted to, and approved by, the Nevada Division of Environmental Protection.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, as amended, and implementing regulations, the Administrator proposes to issue Permit NS2007504 to discharge for a five (5) year period, subject to certain effluent limitations.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance, or request a hearing pursuant to the Nevada Administrative Code, Water Pollution Control, should submit their comments or request, in writing, within thirty (30) days of the date of newspaper publication, hand delivered or postmarked no later than 5:00 P.M. on 03/28/2013, either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determination(s) regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.
