NOTICE OF PROPOSED ACTION

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and/or the Clean Water Act, where applicable. The Administrator has received an application for a Groundwater Discharge, permit number NS0090009 from the following applicant:

Permit NS0090009, TONOPAH CONSERVATION CAMP:

The applicant, Nevada Department of Corrections (NDOC), has applied for renewal of groundwater discharge permit NS0090009 (formerly NEV90009). NDOC owns and operates the Tonopah Conservation Camp, a minimum-security men's prison camp located approximately 6.9 miles north of the junction of US-6 and SR-376 in Big Smoky Valley, Nye County, Nevada. The facility operates two 10,000-gallon capacity septic tanks to provide primary (settling) treatment of the camp's domestic wastewater. Septic tank effluent is discharged to groundwater of the State via subsurface percolation.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, as amended, and implementing regulations, the Administrator proposes to issue Permit NS0090009 to discharge for a five (5) year period, subject to certain effluent limitations.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance, or request a hearing pursuant to the Nevada Administrative Code, Water Pollution Control, should submit their comments or request, in writing, within thirty (30) days of the date of newspaper publication, hand delivered or postmarked no later than 5:00 P.M. on 02/28/2014, either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determination(s) regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.
