PUBLIC NOTICE

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Division of Environmental Protection is issuing the following notice.

The Director received an application for a new Class II Air Quality Operating Permit AP1041-3586 from:

Newmont Mining Corporation

Elko, Nevada 89801-2800

The Newmont Mining Corp. facility will be located at 688 Johnson Ranch Road Elko, Nevada. The Newmont Mining Corp. facility will be located approximately at UTM 710.80 km East by 4,54.04 km North, Zone 11 (Sections 11-15, 17, 19-36, Sections 1-6, 9-16, Sections 24, 25, Townships 35, 36 North, Range 66 East in Hydrographic Area 187, Goshute Valley). The Director has prepared tentative determinations regarding the operating permit that, in brief, are the following:

- The new permit is for operation of a gold mining facility.
- Emissions from the facility will not exceed 0.75 tons/year of PM₁₀, 0.70 tons/year of PM_{2.5}, 5.93 tons/year of NO_x, 0.03 ton/year of SO₂, 1.36 tons/year of VOC, 5.25 tons/year of CO, and 0.084 tons/year of combined HAPs.
- No adverse ambient air quality impacts are expected.

On the basis of the preliminary review of the application and supporting information review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing her intent to issue a new Class II Air Quality Operating Permit.
