

NOTICE OF PROPOSED ACTION

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Division of Environmental Protection is issuing the following Notice of Proposed Action.

The Director received an application for a Class I (Title V) Operating Permit, AP1041-3668 (FIN A1915) from the following applicant:

WK MINING (USA) LTD.

WK Mining (USA) Ltd., Three Hills Mine Project is located approximately 1-1/2 miles west of Tonopah, Nevada in Esmeralda County. The project is located in all or portions of the following area(s): Sections 3, 4, and 5, Township 2N, Range 42E and Sections 33 and 34, Township 3N, Range 42E (MDB&M). The Director has prepared a tentative determination regarding the proposed Class I (Title V) Operating Permit. In brief, the project includes the following:

- WK Mining (USA) Ltd. proposes to construct and operate an Adsorption-Desorption-Recovery (ADR) plant to support open-pit mining activities at their Three Hills Mine Project near Tonopah, Nevada. The proposed draft Title V permit contains only those affected sources subject to 40 CFR Part 63, Subpart EEEEEEE, which includes certain components of the proposed ADR plant. Other equipment and processes at the Three Hills Mine will be covered in a separate minor source air quality operating permit.

On the basis of the preliminary review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue the proposed Class I (Title V) Operating Permit based on a review of the information submitted. A copy of the draft permit will be available for public inspection at the following location:
