Dear Dr. Siders:

Cardno ATC, on behalf of our client, is requesting that the fourth quarter 2012 monitoring event be limited to wells MW-34 to MW-40 and that the first quarter 2013 monitoring event be changed so that all wells are sampled, including the new deeper wells that are proposed to be installed in January 2013. Cardno ATC would perform the first quarter 2013 monitoring and sampling event following installation of the deeper wells.

The current groundwater sampling schedule for fourth quarter 2012 is as follows:

- > MW-1 through MW-39 (with the exception of MW-4 which was abandoned), MW-14I, and MW-19I (plus any newly installed wells).

The current groundwater sampling schedule for first quarter 2013 is as follows:

- > MW-1, MW-5, MW-6, MW-9, MW-14, MW-17, MW-27, MW-34, MW-35, MW-36, and MW-37 (plus any newly installed wells).

The following is the proposed sampling schedule for fourth quarter 2012 and first quarter 2013:
