The Administrator of the Division of Environmental Protection (NDEP) gives notice that an application for a renewal of a Water Pollution Control Permit for the Mount Hope Project, a mining and beneficiation facility, has been properly filed with NDEP in Carson City. The Applicant for renewal of Water Pollution Control Permit NEV2008106 (Permit) is:

The facility is located on public and private land in Eureka County, within Sections 5, 8, 9, 16, 21, 26-28, 34, 35, and 36, T20N, R52E; Sections 31-35, T20N, R53E; Section 2, T20½N, R51E; Sections 1, 4-9, 12, 18-20, 29, and 32, T21N, R51; Sections 7, 18-20, 29 and 32 T21N, R52E; Sections 4-6, T21½N, R52E; Section 1, T21½N, R51½E; Sections 1, 2, 11-14, 23-27, and 36, T22N, R51E; Sections 1, 12, 13, 24, 25, and 36, T22N, R51½E; Sections 6-8, 17-20, 29, 30, 31, and 32, T22N, R52E; Sections 25, 35, and 36, T23N, R51E; and Section 31, T23N, R52E, MDB&M, approximately 24 miles northwest of the town of Eureka.

The Project consists of an open pit mining and chemical processing facility, pursuant to Nevada Administrative Code (NAC) 445A.394.

The Administrator is constrained to either issue the renewed Permit or deny the application. The Administrator has made the tentative decision to issue the renewed Permit.

Persons wishing to comment on the proposed Permit, recommend terms and conditions for consideration of incorporation into the Permit, or request a public hearing pursuant to NAC 445A.403, must submit their written comments, objections, or requests by hand delivery, U.S. Postal Service, facsimile, or e-mail transmittal, no later than 5:00 PM on the 30th day following the date of publication of this notice (submittal end date **December 06, 2025**) to:

All comments, objections, or requests received during the public notice period will be considered in the final determination regarding the Permit. If NDEP determines that written comments or requests indicate a significant degree of public interest in this matter, the Administrator shall schedule a public hearing in accordance with the requirements of NAC 445A.405.
