**Permanent Regulation R145-24 (P2024-21):** The NDEP is proposing revisions to Nevada Administrative Code (NAC) 519A.392: Payments for deposit into a Fund; use and reimbursement of the money in the Fund. The change seeks to increase funding to the Trust Fund for Short-Term Fluid Management to ensure the State can manage process fluids at a mining operation in case of operators' default, until the posted surety can be utilized, at which time the fund will be replenished.
