NDEP's Air Program and the GOE have been working with SSG on identifying preliminary emissions reductions measures for the Climate Pollution Reduction Grant's (CPRG) Priority Climate Action Plan (PCAP) development. The intent of the PCAP is to identify near-term and implementation-ready strategies, initiatives, and other projects that aim to reduce emissions of greenhouse gases and other pollutants.

A Comprehensive Climate Action Plan (CCAP) engagement process will begin later in 2024. Outreach events are held to establish meaningful and on-going engagement with all interested parties, especially low-income and disadvantaged communities, during development. Public and stakeholder comments to improve outreach and engagement efforts are encouraged and always ongoing.
