FEDERAL FACILITY AGREEMENT AND CONSENT ORDER

(FFACO) QUARTERLY REPORT

Background

The Federal Facility Agreement and Consent Order (FFACO) is a legal document by which the Nevada Division of Environmental Protection (NDEP) assures citizens of Nevada that the public's health and safety, as well as the environment, are protected in regards to the Nevada National Security Site (NNSS), parts of the Nevada Test and Training Range (NTTR), parts of the Tonopah Test Range (TTR), and the two Nevada Off-Sites, Central Nevada Test Area (CNTA) and Project Shoal Area (PSA). Nevada Off-Sites are a group of sites where underground nuclear tests occurred out of the boundaries of the NNSS.

The FFACO identifies sites of potential historic contamination that require corrective actions based on public health and environmental considerations on the NNSS, the NTTR, the TTR, CNTA, and PSA.

Industrial Sites Activity

At the end of September 2025, there were 1962 historical Corrective Action Sites (CASs) (out of 1970 total) that have been closed, with three (3) CASs in Corrective Action Unit (CAU) 114 and five (5) CASs in CAU 572, all of which continue to undergo active D&D work by the Department of Energy's Environmental Management Nevada Program (EM NV).

The Nevada Division of Environmental Protection Bureau of Federal Facilities' (NDEP or BFF) staff continued document reviews, Use-Restrictions reviews, and post-closure inspections for a number of closed Industrial Sites on the Nevada National Security Site (NNSS), as described below:

Document Reviews and Letters:

CAU 114 – Area 25 Engine Maintenance, Assemble, and Disassembly (EMAD) Facility – On December 23, 2024, BFF received the Draft SAFER Plan for CAU 114: Area 25 EMAD Facility, NNSS, Nevada, Revision 1, December 2024. A response letter with comments was issued on May 8, 2025. On July 31, 2025, BFF received the *Final Streamlined Approach for Environmental Restoration (SAFER) Plan for Corrective Action Unit (CAU) 114: Area 25 EMAD Facility, Nevada National Security Site, Nevada,*

Revision 1, July 2025. A response letter approving the Final SAFER was issued on August 5, 2025.

CAU 572 – **Test Cell C** – On September 16, 2025, BFF staff received *EM Nevada (EM NV) Program's Application of Point of Generation Guidance at Federal Facility Agreement and Consent Order (FFACO) Site.* A response letter was issued on September 30, 2025.

Meetings and Site Visits:

A monthly FFACO meeting is held between BFF and EM NV personnel to discuss any relevant topics and the status of correspondence. Meetings were held on July 10 and August 21, 2025.

On August 12, 2025, BFF chief and staff attended two meetings with the DOE EM NV. The first meeting was regarding data validation. The second meeting was to discuss waste at CAU 572: Test Cell C.

On September 11, 2025, BFF staff traveled to the NNSS to accompany the DOE EM NV and the Deference Threat Reduction Agency (DTRA) on a tour of the CAUs that DTRA are responsible for.

As the demolition of CAU 114: EMAD and CAU:572 Test Cell C progresses, BFF staff have observed the ongoing demolition activities to ensure regulatory compliance. This quarter's site visits occurred on July 9, July 21, August 6, August 14, August 20, and September 2, 2025.

Soils Activity Sites

At the end of December 2019, all Soil CASs, a total of 144, had been closed.

Underground Test Area (UGTA) Activity

There are five (5) UGTA CAUs, all of which are either in the Corrective Action Decision Document/Corrective Action Plan (Model Evaluation for UGTA sites) or in long-term monitoring during the Closure Stage. During this quarter, BFF staff participated in the process of document review, project evaluation, site visits, meetings and/or teleconferences for the UGTA Activity and CAUs 101 and 102 – Central and Western Pahute Mesa in the following ways:

Document Reviews and Letters:

On May 20, 2025, BFF staff received the *Final Calendar Year (CY) 2024 Post-Closure Monitoring Letter Report, Revision 0, May 2025*. A response letter with comments was issued on June 10, 2025. On July 16, 2025, BFF received the *Submittal of the Final Calendar Year 2024 Post-Closure Monitoring Letter, Revision 1, July 2025*. A response letter accepting the document was issued on July 29, 2025.

On July 2, 2025, BFF received the *Draft Calendar Year 2024 Underground Test Area (UGTA) Annual Sampling Letter Report, NNSS, Nevada, Revision 0, July 2025.* A response letter with comments was

issued on July 30, 2025. On September 4, 2025, BFF staff received the Submittal of the Final Calendar Year (CY) 2024 Underground Test Area (UGTA) Annual Sampling Letter Report, Nevada National Security Site, Nevada, Revision 1, September 2025. A response letter accepting the document was issued on September 8, 2025.

On September 29, 2025, BFF received the Request for Notice of Completion on Corrective Action Unit (CAU) 101: Central Pahute Mesa and CAU 102: Western Pahute Mesa Model Evaluation Data Presentation # 1 Milestones. A notice of completion letter for the milestones was issued on September 30, 2025.

Meetings and Site Visits:

Informal UGTA Discussion Meetings – A practice was begun in the beginning of 2022 of holding an "informal" Teams meeting with EM NV, Navarro, DRI and BFF staff about every six weeks to discuss present and upcoming UGTA documents or activities or any other outstanding UGTA subjects. This quarter's meeting was held on September 18, 2025. This quarters meeting was held at the same time as the Model Evaluation Presentation on September 18, 2025.

On September 18, 2025, BFF chief and staff attended the Model Evaluation Presentation #1 for CAUs 101 and 102: Central and Western Pahute Mesa.

Nevada Off-Sites and the Tonopah Test Range

There are four (4) Nevada Off-Sites CAUs, two (2) Surface CAUs (CAU 416 and 417) and two (2) Subsurface CAUs (CAU 443 and 447). CAU 416 has been clean closed. CAU 417 is in Post-Closure Monitoring. CAUs 443 and 447 are in the Closure Stage. On September 30, 2020, the Office of Legacy Management (LM) assumed responsibility for the long-term surveillance and maintenance of the Tonopah Test Range (TTR) FFACO sites. NDEP activities for the TTR sites are reported under this Section.

CAU 447: Project Shoal Area – BFF received the *Draft Postclosure Groundwater Monitoring and Inspection Report, Project Shoal Area: Subsurface Corrective Action Unit 447*, on May 28, 2025. BFF issued a comment response letter on June 26, 2025. BFF received responses to NDEP comments on the Draft Shoal 2024 Report on July 29, 2025. BFF accepted the comment responses on August 4, 2025.

Meetings and Site Visits:

On July 1, 2025, BFF supervisor and staff attended a meeting with DOE LM and their contractor to discuss and resolve comments regarding the *Draft 2024 Postclosure Groundwater Monitoring and Inspection Report, Project Shoal Area: Subsurface Corrective Action Unit 447.*

On September 9, 2025, BFF chief, staff, and a NDEP deputy administrator traveled to Fallon, Nevada to

attend the annual inspection and groundwater monitoring event at CAU 447: Project Shoal Area.

General FFACO Business:

Federal Facility Agreement and Consent Order (FFACO) – On July 7, 2025, BFF issued the *Notification of the Nevada Division of Environmental Protection, Bureau of Federal Facilities' Designated Federal Facility Agreement and Consent Order (FFACO) Agreement Coordinator and Corrective Action Coordinator.* On July 21, 2025, BFF issued an updated *Notification of the Nevada Division of Environmental Protection, Bureau of Federal Facilities' Designated Federal Facility Agreement and Consent Order (FFACO) Agreement Coordinator and Corrective Action Coordinator.*

Fiscal Year 2025 – 2026 Planned (FFACO) Milestones and Due Dates – On August 21, 2025, BFF staff received the *Distribution of Fiscal Year (FY) 2025+1 Milestone Chart and Listing of Modifications to the Federal Facility Agreement and Consent Order (FFACO)*. A response letter with comments was issued on August 29, 2025. On September 4, 2025, BFF staff received the *Response to Distribution of FY 2025+1 Milestone Chart and Listing of Modifications to the Federal Facility Agreement and Consent Order (FFACO)*.

Use Restriction Management Plan - On July 31, 225, BFF staff received the *Draft Federal Facility Agreement and Consent Order (FFACO) Nevada National Security Site (NNSS) Use Restriction Management Plan, Revision 2, July 2025.* BFF issued a response letter on August 5, 2025. On September 3, 2025, BFF staff received the *Final Federal Facility Agreement and Consent Order (FFACO) Nevada National Security Site (NNSS) Use Restriction Management Plan (URMP), Revision 2, August 2025.* A response letter approving the document was issued on September 8, 2025.

Use Restrictions (URs) and General FFACO Work – Throughout this quarter, BFF staff have reviewed updated URs submitted by the EM NV. Comments are offered when necessary. The Use Restriction Management Plan (URMP) will be periodically revised by the EM NV to add updated NDEP-accepted URs.

FFACO Transition – As the active investigation/remediation work under the FFACO nears completion, the Department of Energy (DOE) and NDEP have undertaken the FFACO Transition Project to ensure that any future steward of the NNSS will be aware of all post-closure monitoring requirements on the NNSS by the addition of Appendix VII to the FFACO. The Bureau Chief represents NDEP on this working group. On February 22, 2024, the Final Agreement to Modify the Federal Facility Agreement and Consent Order (FFACO) (Agreement) was emailed to all Signatory Agencies. On August 28, 2025, BFF received the Transmittal of the Modification to the Federal Facility Agreement and Consent Order (FFACO).

On July 2, 2025, BFF chief, supervisor, and staff attended the FFACO Transition Meeting.

Affirmation Forms – As the active investigation/remediation work under the FFACO nears completion,

in addition to the FFACO Transition project, a Closure Affirmation Form project was undertaken by EM NV and Navarro to ensure that the documentation for the closure of each CAU identified in the FFACO, inclusive of its associated corrective action sites, is complete in accordance with FFACO standards. Each Closure Affirmation Form requires acceptance through signature by the Bureau Chief. This project was completed at the end of June 2025.

File Management – This quarter, staff have continued to organize, scan for electronic storage, and document files for FFACO sites.

Miscellaneous:

The chief, and in her absence the supervisor, participated in monthly NDEP Attorney General staff meetings, bi-weekly Division-Wide Chief's Staff Meetings and bi-weekly meetings with the Deputy Administrator either in person or via virtual meetings in July, August, and September 2025.

During this quarter, the bureau chief attended or participated virtually in: (1) numerous calls, meetings and/or webinars as a member of the NGA's Federal Facilities Task Force (FFTF), the State, Tribal, Government Working Group (STGWG), the Environmental Council of States (ECOS) and/or the Combined Intergovernmental Working Group (CIWG) Planning Committee; (2) two Nevada Site-Specific Advisory Board meetings; (3) regular bureau staff meetings and meetings with individual staff; (4) the quarterly Low-Level Waste Stakeholders meeting; (5) a number of meetings with various DOE staff on both FFACO and Waste topics.

Tribal Interaction – During several virtual and in-person meetings this quarter with the State, Tribal, Government Working Group, the bureau chief and staff interacted with a number of Tribes throughout the United States who have ties to the actions of the Department of Energy.

BFF staff completed 24 Hour HAZWOPER training.

Agreement in Principle (AIP) Functional Areas Summary – Grant #DE-EM0005237 0003

Background

The Agreement in Principle (AIP) is a legal document by which the Nevada Division of Environmental Protection (NDEP) assures citizens of Nevada that the public's health and safety, as well as the environment, are protected in regards to the Nevada National Security Site (NNSS). Under the AIP, the Bureau of Federal Facilities (BFF) serves as the primary point of contact for environmental compliance matters for past and ongoing operations at the NNSS.

The BFF enforces environmental regulations at the NNSS through the issuance of permits to the owner of the NNSS, Department of Energy's (DOE's) National Nuclear Security Administration/Nevada Field Office (NNSA/NFO). The BFF issues Water Pollution Control Permits GNEV93001 and NEV96001, Resource Conservation and Recovery Act (RCRA) Permit NEV HW0101, and Solid Waste Permits SW 532, SW 13 097 02, SW 13 097 03, and SW 13 097 04. The BFF also regulates Safe Drinking Water Permits NV0000360, NV0004098, and NV0004099.

1. On-Site Discharges - Water Pollution Control

There is currently zero (0) waste generator suspensions.

Active Profiles:

There are currently 214 active profiles, comprised of 52 Mixed LLW/Hazardous non-rad profiles, 27 LLW/Non-Rad Solid Waste profiles and 135 LLW profiles.

Suspended Profiles:

There are currently zero (0) profiles under suspension.

Site Visits/Radioactive Waste Generator Facility Evaluations:

The Radioactive Waste Acceptance Program (RWAP) conducted four (4) surveillances, two (2) audits, and no split sampling events this quarter. NDEP participated in three (3) surveillances, and two (2) audits this quarter as described in the sections below.
