## NOTICE OF PROPOSED ACTION

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and/or the Clean Water Act, where applicable. The Administrator has received an application for a Groundwater Discharge, permit number NS2008510 from the following applicant:

PAR 3, LLC CONESTOGA GOLF CLUB 1499 FALCON RIDGE PARKWAY MESQUITE, NV - 89034

## Permit NS2008510, CONESTOGA GOLF COURSE AT ANTHEM MESQUITE:

The Permittee, Par 3 LLC, has applied for a renewal of groundwater discharge permit NS2008510 to utilize tertiary treated, denitrified, and disinfected effluent for reuse irrigation and dust control for new construction. The irrigated areas consist of the golf course fairways, tees, greens, landscaping, and driving range for the Conestoga Golf Course at Anthem Mesquite (CGCAM) located at 1499 Falcon Ridge Parkway, Mesquite, NV 89034. The reclaimed water will be supplied by the City of Mesquite Wastewater Treatment Facility (MWTF) permit NS0040011 to meet irrigation needs. Reuse irrigation will be conducted in accordance with the Reclaimed Water Management Plan (RWMP) and terms and conditions of the permit. Water quality monitoring will be required. Flow monitoring shall be at the CGCAM irrigation lake pump station.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, as amended, and implementing regulations, the Administrator proposes to issue Permit NS2008510 to discharge for a five (5) year period, subject to certain effluent limitations.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance should submit their comments or request, in writing, hand delivered or postmarked no later than 5:00 P.M. on 06/11/2024, either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determination(s) regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.

A public hearing on the proposed determination can be requested by the applicant, any affected State, any affected interstate agency, the Regional Administrator of EPA Region IX or any interested agency, person or group of persons. The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. Any public hearing determined by the Administrator to be held must be conducted in the geographical area of the proposed discharge or any other area the Administrator determined to be appropriate. All

public hearings must be conducted in accordance with NAC 445A.238.
