

**NOTICE OF PROPOSED ACTION**

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and/or the Clean Water Act, where applicable. The Administrator has received an application for a Groundwater Discharge, permit number NS2025509 from the following applicant:

**Permit NS2025509, GREENLINK WEST:**

The Applicant, Power Engineers, Inc., has applied for a new individual working in waterways permit for the "Greenlink West" project. The approximately (400) mile long project corridor is located along and South of U.S. Route 95 on public land managed by the Bureau of Land Management between the existing NV Energy (NVE) Harry Allen Substation and extends north to the Walker River Substation (north of Yerington), in Storey, Lyon, Mineral, Esmerelda, Nye and Clark Counties. The applicant is proposing to operate heavy equipment (rolling stock) within two (2) sections of the Carson River and four hundred and thirty-four (434) unnamed washes for the construction a 525 Kilovolt (kV) transmission line. Best Management Practices (BMPs) shall be utilized to prevent erosion and degradation of waters of the State. No discharges to waters of the State and/or waters of the U.S. are anticipated.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, as amended, and implementing regulations, the Administrator proposes to issue Permit NS2025509 to discharge for a five (5) year period, subject to certain effluent limitations.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance should submit their comments or request, in writing, hand delivered or postmarked no later than 5:00 P.M. on 04/18/2025 , either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determination(s) regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.

A public hearing on the proposed determination can be requested by the applicant, any affected State, any affected interstate agency, the Regional Administrator of EPA Region IX or any interested agency, person or group of persons. The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. Any public hearing determined by the Administrator to be held must be conducted in the geographical

area of the proposed discharge or any other area the Administrator determined to be appropriate. All public hearings must be conducted in accordance with NAC 445A.238.

The final determination of the Administrator may be appealed to the State Environmental Commission pursuant to NRS 445A.605.
