NOTICE OF PROPOSED ACTION

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and/or the Clean Water Act, where applicable. The Administrator has received an application for a Groundwater Discharge, permit number NS0090001 from the following applicant:

PRIMM VALLEY RESORTS 31900 LAS VEGAS BLVD. SO PRIMM, NV - 89019

Permit NS0090001, PRIMM WASTEWATER TREATMENT PLANT:

The Permittee, Primm Valley Resorts, has applied for the renewal of Permit NS0090001 for the Primm Wastewater Treatment Plant (PWWTP), at 32250 Fashion Outlet Way, located in Primm, being within Clark County, Nevada. The Permittee proposes to continue to discharge treated effluent to groundwater of the State either via multiple rapid infiltration basins (RIBs), or reclaimed water via connection to NV Energy's Walter M. Higgins III Generating Station (560 MW Summer Peaking Plant) for plant makeup water (permit NS2002500), and/or applied irrigation use and dust control.

The PWWTP utilizes a pre-manufactured, activated sludge/extended aeration "package" plant, produced by MAR-WOOD, to secondary treat the wastewater to a Category B bacteriological level, as defined under Nevada Administrative Code (NAC) 445A.276, which is both denitrified and disinfected. The plant was designed for a maximum daily flow rate of 1.0 million gallons per day (Mgal/d) of domestic sewage. The treatment plant services three hotels and casinos, employee housing units (460 apartments), a California Lotto store, two gas stations, and various restaurants.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, as amended, and implementing regulations, the Administrator proposes to issue Permit NS0090001 to discharge for a five (5) year period, subject to certain effluent limitations.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance should submit their comments or request, in writing, hand delivered or postmarked no later than 5:00 P.M. on 06/02/2025, either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determination(s) regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.

A public hearing on the proposed determination can be requested by the applicant, any affected State, any affected interstate agency, the Regional Administrator of EPA Region IX or any interested

agency, person or group of persons. The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. Any public hearing determined by the Administrator to be held must be conducted in the geographical area of the proposed discharge or any other area the Administrator determined to be appropriate. All public hearings must be conducted in accordance with NAC 445A.238.
